If no one can be reached, however, please indicate your wishes should your pet require treatment to relieve immediate discomfort or to resolve important medical conditions.

- Please perform whatever services the doctor deems necessary for the best care of my pet until someone can be reached. This includes only non-elective procedures and necessary diagnostics.
- I authorize up to: \$ 50 \$100 \$ _____ in medical care until someone can be reached
- Do Not administer any medical treatment until specific authorization is given.

- I understand that the staff of Firgrove Veterinary Clinic uses all reasonable precautions against injury, escape or death of my pet while boarding. The clinic and staff will not be held liable for any problems that develop such as self inflicted injuries or illnesses contracted from the other boarding pets (kennel cough, stress related diarrhea or vomiting), provided reasonable care and precautions are followed.
- I understand that any problem that develops with my pet while I am gone will be treated as deemed best by the staff veterinarians and according to my instructions given on the medical illness policy statement on this form.
- I also understand that all services other than the daily boarding rate have additional charges, and I will be responsible for these charges at the time my pet(s) are picked up from boarding.
- I expect the doctor-client privilege at Firgrove Veterinary Clinic to be observed and understand that my pet is under the direct supervision of a veterinarian while at the clinic. I do not authorize the release of any information regarding my name, address, phone number or pet's information to any other organization or business without my express permission.
